

# **ADDENDUM To Hotel Local Leisure Wholesale FIT Agreement 2025-2026**

This Addendum ("Addendum") is made on [14 Oct 2025], and forms part of the Hotel Contract ("Agreement") originally executed under the name of Leisure Wholesale FIT Rate Agreement 2025- 2026

\*\*[Hotel Local] \*\*, will be knowns starting from **04**<sup>th</sup> **Nov 2025** as \*\*[ Hotel Local Dubai, Jumeirah Village Triangle, Autograph Collection] \*\*, located in Dubai Jumeirah Village Triangle

## **Purpose of Addendum**

The purpose of this Addendum is to formally record and agree upon the following changes to the existing Agreement:

### 1. Change of Hotel Name

Effective 04<sup>th</sup> November 2025, the hotel formerly known as [Hotel Local] has officially changed its name to [Hotel Local Dubai, Jumeirah Village Triangle, Autograph Collection]. All references to "[Hotel Local]" in the Agreement shall henceforth refer to [Hotel Local Dubai, Jumeirah Village Triangle, Autograph Collection]. Since we have partnered with Marriott as Franchise Brand of Autograph Collection, we added the name of Autograph Collection. Hence, it does not affect ownership, management, or the terms and conditions of the Agreement unless otherwise stated.

### 2. Change in Room Types and Rate Structure

The following revisions to Room Types and Rate Structure are hereby agreed upon:

- A New Room Category has been created as Deluxe Skyline Room (It's the same unit of Deluxe Room, but in High Floors)
- Superior Room remains the same
- Executive Room has its name changed to Club Room ( which is Deluxe Room with Club Access)
- Junior Suite has been removed and Executive Suite's Name has been changed into Club Suite (which is Junior Suite with Club Access )
- Kindly follow the new rate structure according to this Memo

All other aspects of the Agreement, including rates, inclusions, terms, finance, bank details shall remain unchanged unless otherwise agreed in writing.
