*** GENERAL HOTEL RULES***

- 1. There is a dress code in the restaurants. (Swimsuits are not allowed.) For your safety and comfort, please do not enter the dining and beverage areas without shoes. (Do not wear flip-flops, slippers with slippery soles, or similar clothing.)
- 2. In accordance with local laws, alcoholic beverages are not served to guests under the age of 18.
- 3. Hotel management reserves the right to refuse service to guests who may be at risk of harming themselves or others after consuming a certain amount of alcohol.
- 4. Check-out time is 11:30 AM. Upon check-out, the room key, guest armband, and towel card must be returned to the reception.
- 5. On the day of check-in, guests can use all services included in the accommodation and concept at 2:30 PM.
- 6. Late check-out and early check-in are subject to a fee.
- 7. Ultra all-inclusive guests may use the food and beverage service exclusively for themselves.
- 8. It is unhygienic to bring food from food and beverage outlets to the pool, beach, and pier sunbed areas. A €20 service fee is charged for bringing food from food and beverage outlets to these areas.
- 9. Food, premium, and specialty beverages requested outside of the buffet are available for a fee.
- 10. Food and beverages served within the facility are subject to a service fee. If detected, a €20 fee will be added to your room bill.
- 11. The beach, pier, and water slides are open to use depending on the weather.
- 12. Dry cleaning services are not provided on-site. Our facility cannot be held responsible for any problems that may occur with this service, which is purchased from external companies for a fee.
- 13. In accordance with local laws, smoking is prohibited in enclosed areas (rooms, lobby, restaurant, etc.). Failure to do so is subject to financial penalties determined by local authorities. To protect our children and guests with health problems from secondhand smoke, smoking is prohibited in the balcony areas of the Main Restaurant during meals.
- 14. Hookahs, irons, etc. are not available in the rooms. The use of personal devices is not permitted. Otherwise, the guest will be charged for the cost of replacing any damage incurred by the guest, including damage resulting from such use within the room and the hotel.
- 15. All hookahs, and similar equipment and devices in the rooms that could pose a fire hazard, will be returned to the management upon check-out. The cost of damage resulting from such use will be charged to the guest.
- 16. Parental supervision is mandatory for use of the water slides, pool, and activity areas.
- 17. Guests using the fitness center are responsible for any health issues that may arise from individual workouts.

- 18. Children are not allowed in the fitness center. Parents are responsible for supervising their children. The hotel management is not responsible for any accidents that may occur due to children using the fitness center that do not comply with the prohibition.
- 19. Guests are not permitted to listen to loud music from portable devices in the rooms or outdoors that may disturb the surroundings. Please respect the right of every guest to silence.
- 20. Throwing any objects, plates, bottles, cigarette butts, and/or garbage from the hotel's windows and balconies is strictly prohibited.
- 21. There are trash cans in the hotel areas for paper, aluminum, glass, and plastic. Please use these areas for your trash.22. In-room safety deposit boxes are available free of charge for your valuables. Our hotel is not responsible for any lost items.
- 22. Armbands are provided at our hotel for the convenience and safety of our guests. Loss charges apply.
- 23. Our hotel's air conditioning system operates centrally. Opening and closing times are automatically determined based on weather conditions.
- 24. Central air conditioning operating hours are determined based on weather conditions.
- 25. The services of private businesses located within the facility are not owned by the hotel and are not the responsibility of the hotel management.
- 26. Our facility regularly conducts pest control and disinfection operations in accordance with international quality standards.
- 27. Snack restaurants and street activities; These may be changed or canceled by the hotel management depending on the season, guest profile, and product availability.
- 28. Parties, entertainment programs, and all other activities may be changed or canceled depending on weather conditions, guest profile, season, and physical factors.
- 29. Rooms are for accommodation purposes only. Each person staying in a room must be registered at the reception desk.
- 30. Unregistered visitors are prohibited from entering the room or other areas within the hotel. An additional fee for one person for unregistered guests will be charged to the guest's account.
- 31. Guests are strictly prohibited from disturbing each other. Guests who engage in unrest or fight within the hotel will be terminated immediately.
